1	The total number of sections of the school from class I to XII shall be restricted to 50, out of which the school can run not more than 14 sections in secondary classes i.e. 7 in class IX and 7 in class X and not more than 16 sections in senior secondary classes i.e. 8 in class XI and 8 in class XII, subject to the condition that the school shall not run more than 1/4 and 1/3 of the total sections running in the school at any point in time at the secondary level and senior secondary level, respectively. Further, the school shall submit compliance on the following mentioned
