MONTHLY DONATIONS AUTOMATIC DEDUCTION PROCESS

Donations will also support routine operational, maintenance and capital improvement expenditures for Organization-owned/operated facilities. To facilitate this, an automatic monthly deduction procedure has been made available to donors. This procedure will facilitate the timely remittance of donations to the Organization on a regular basis and will eliminate the need for writing cheques. To participate in this method of donation to the fund, please follow these steps:

- 1. Determine the donation amount to be deducted directly from your bank account on a monthly basis. This amount should be in any multiple of \$25 (\$25, \$50, \$75, \$100, etc.). The amount you choose will be deducted from your account on or about the 15th day of every month, and the Organization's account will be credited the same day.
- 2. Complete the signup form below and provide a voided blank cheque from the account to be deducted each month. Please note that every effort is made to ensure the privacy of personal information in this process.
